With reference to your Letter No. 246 / कु०स० / अविवाहिविवि / 2012 dated 26.07.2012 on the above subject, I am directed to say that Atal Bihari Vajpayee Hindi Vishwavidyalaya, Bhopal has been established by an Act (No. 34 of 2011) – ATAL BIHARI VAJPAYEE HINDI VISHWAVIDYALAYA ADHINIYAM, 2011 of State Legislature of Madhya Pradesh as a State University vide Notification No. 7360 438 इनमीस अ-(प्रा.) dated 19.12.2011 and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its main campus in regular mode with the approval of its statutory bodies/councils, wherever required.

The University is not allowed to start any off-campus centre beyond the territorial jurisdiction of the State as per Hon'ble Supreme Court Judgement in Prof. Yash Pal vs State of Chhattisgarh case.

The University may note and adhere to the following: -

- To ensure that no off campus centre(s)/study centre and the centres operating through franchises is opened by the University outside the territorial jurisdiction of the State in view of the judgement of Hon'ble Supreme Court of India in case of Prof. Yashipal vs. Government of Chhattisgarh.
- ii) In case the university has already started any off-campus/study centre and the centre operating through franchises outside the State, it must be closed immediately.
- No distance education programmes shall be started without the prior approval of Distance Education Council as it is the regulatory body for distance education programmes.

The Dewersity to conduct Ph.D. programmer as per the conscious of UGC (Minimum Standards and Procedure for Awards of M Phil/Ph.D. Degree) Regulations, 2009.
